This requirement will increase to two PSAs and crawls per quarter per day on April 1, 2008, and to three of each on October 1, 2008. Stations are required to air PSAs or crawls at various times in any given day part, and at least one PSA and one crawl per day must be run during primetime hours. On-air education must not contain inaccurate or misleading statements and must be provided in the same language as a majority of the programming carried by the station. PSAs must be at least 15 seconds, and closed-captioned. Crawls must run during programming for no fewer than 60 consecutive seconds across the bottom or top of the viewing area (See rules for additional details).

Pursuant to DA 08-757, the reporting period covered by the instant report only includes one day, March 31, 2008. Nonetheless, this report provides information about voluntary measures taken by the Station prior to the effective date of the applicable rule. PSAs aired this quarter were the 30 second NAB "DTV Answers" spot and a locally produced "DTV Deadline" spot. The NAB spot ran 73 times and the local spot ran 191 times between 5 am and 1 am. The "DTV Deadline" spot is 30 seconds and the script is: "Here are KELOLAND TV, we want you to know about a change in television broadcasting. After February 17, 2009, all television stations will only broadcast a digital signal. This will only affect viewers with an older analog television who receive TV programming over the air with an antenna. Your old TV will still work with a low cost converter box. The federal government is offering coupons for converters. To find out more, see DTVanswers.com or visit our website at KELOLAND.com."

We also aired the local "DTV Deadline" PSA on our multicast digital station 249 times between 5:00am and 1:00am over the last quarter.

Crawl text is: "On February 17, 2009, TV stations including KELOLAND TV will end analog broadcasting and only broadcast a digital signal. Viewers with older analog televisions may lose their signal unless they take action. Get more information online at KELOLAND.COM or by calling 1-888-DTV-2009."
